# POLICE LAUNCH A MANHUNT AFTER A MAN FROM TAXI INDUSTRY WAS SHOT AND KILLED



Shooting incident at Miliva traffic circle on Moloto road.

**TWEEFONTEIN** - Mpumalanga police launched a vigorous manhunt for ruthless suspects following a despicable incident wherein which a 42-year-old taxi owner who also held an executive position within the leadership structure, was unfortunately shot in execution style on Friday 23 April 2021 at Miliva traffic circle, few meters away from the Miliva Taxi Rank in Tweefontein.

The man was shot by a group of heavily armed men who were driving in a white Ford Fiesta who fired several shots at him while he was sitting in his car, a silver grey Toyota Yaris. The assailants thereafter fled the scene,

leaving him bleeding profusely. The victim was then taken to hospital where he succumbed to his injuries.

In March 01, 2021 a 39-year-old France Oupa Manamela who was a Taxi Marshall, was gunned down in execution style at Miliva Taxi Rank. Preliminary investigation revealed that France was shot by four suspects driving in a silver VW Polo. They fled the scene immediately after committing this heinous act and are still at large.

Meanwhile, 31-year-old Kenny Sipho Mahlangu who was a taxi driver, was shot and killed at Tweefontein on 07 March 2021. Details around this incident reveal that Mahlangu was driving in a white Isuzu bakkie when he was

attacked. On the said day, it is alleged that he was followed by a certain Toyota Run-X and shots were fired from the said vehicle which resulted in him being fatally wounded.

Two other victims were both gunned down on 15 March 2021. It is said that at about 17:30, Jeremia Nkosinathi Chabangu, aged 44 was shot and killed by a group of suspects whilst sitting inside a Mercedes Benz Minibus at KwaMhlanga Crossroad. The suspects then fled the scene in a white VW Golf

7. Whilst 65 year Piet Mahlangu was shot and killed around 20h40 during the time when he was with his family at home. The incident occurred at Boekenhouthoek near Kwaggafontein

and two suspects are said to have been seen wearing balaclavas earlier. They then fled the scene in a white Toyota Quantum after the incident. His wife also sustained some injuries on her leg.

Police urge anyone with information that may lead to the arrest of the suspects to contact Detective Lieutenant Colonel Difaga John Malope at 0824417591, or call the Crime Stop number at 08600 10111. Alternatively, members of the public can send information via MYSAPSAPP. All received information will be treated as confidential and callers may opt to remain anonymous.

# Yazi kabanzi ngevunulo yabomma

KwaNdebele sizikhakhazisa ngamasiko nobuhle bobukghwari besikhethu. Hlangana nokhunye sizithokozisa ngomvumo negido, ilimi, izidlo nemikhosi, ikambiso yamaNdebele kanye nevunulo. Namhlanjesi-ke khesindlaleni le yevunulo yabomma.

Kokuthoma siba nomntazinyana, sibe netlawana kanye netlawu. Umntwana womntazana kusukela ekubelethweni kwakhe sithi mntazinyana. Wathoma wahlakanipha wakwazi ukuzenzela izinto, wakwazi nokuthumeka sithi litlawana. Bese ngale kwalapho, sele aphuhle namabele alungele ukuthomba sithi litlawu. Itlawu lona belembatha irhabi, isikhunjana sembuzi esitjhukiweko, imidzegana emibili edinini, imidzegana emibili enyaweni ngalinye bese ufaka nomncamo entanyeni umrivathi.

Kuthi angadlula, namkha ngithi ngemva kobana athombe sithi lithelerina. Ithelerina lona lembatha irhabi, iphephethu phezu kwerhabi, isithimba ukuvala ilingemuva, kanye neenrholwani ezimbili edinini ekuyijuba nobukhobe. Yeleda bona itjhuguluko elibekhona evunulweni ngebanga letjhuguluko yendlela yokuphila likhulu. Ivunulo le yethelerina seyivunulwa kwaphela umntazana nakayokuphathisa namkha ukungenisa. Ekadeni levunulo ebalwe ngehla bekuyinto yangamalanga. Bese kuthi umntazana nakaphumako ayokuhlangana neentanga zakhe avele aphose ikumbese namkha umbhalo neraso entanyeni, ibhayi namkha umtsurhwa-na kanye namatekisana.

Ekadeni umntazana oyokuphathisa namkha ukungenisa beka rhuna zoke iinhluthu ehloko. Leyo yikambiso yesikhethu engasalandelwako. Ngomgqibelo amathelerina nakagidela ijemu, bambatha iphephethu, isthimba, isiveni, ijuba nobukhobe edinini,

iyerhana, iraso, umkhala, amatekisana, neerholwani ezine enyaweni ngalinye. Iinrholwani zenyaweni nazo zitjhugulukile. Ngaphambilini, besine tjhukelana, ilihlo lekomo, ispinyana njalonjalo. Kodwana zoke lezo azisekho sekusele kwaphela ijuba nobukhobe nezinye. Kwethelerina kutjhagala njalo ngerhodlweni uzikhakhazise ngefigara neenkono ezikhombileko.

Nakwenzeka bona umuntu lo esithi litherina umntazana wequde, uZimu ambusise ngomntwana akusese lithelerina, lithari. Ithari njekonina likasigede kufuze limbathe ngokuhlonipheka. Ithari alimbathi irhabi, alimbathi iyerhana, alimbathi imidzegana, begodu alikhambi ngomzimba njengomntazana. Phezu kwephephethu nesithimba, ekadeni ithari belimbatha isikhumba sembuzi ekulu esikazi.

Iskhumbesi besifakwa entanyeni sehle nesifuba sifike enzasanyana kwedini, sidlulele ngemuva sehle nomgogdlha sifike ngehlangana kwamadolo. Umntazana ngaphandle kokuthi abelithari, ubamdzidlha. Umdzidlha mntazana osele akhulile alungele ukwenda. Ngaleso skhathi akhule njalo kodwana asahlala ngakwabo sithi mdzidlha. Ivunulo yomdzidlha ifana neyethari.

Nakwenzeka bona ithari namkha umdzidlha afunyane umendo, akasese mdzidlha, kodwana ngumalokazana. Umalokazana singahlathulula sithi mumuntu wengubo osandukwenda, ongakabuyisi amehlo. Umalokazana akanamuzi kodwana uhlala ngeqathaneni.

Khumbula bona umuntu nakayokwenda, ukhamba ambethe isintazana. Iirholwani, umbhalo njalonjalo. Nakafika emendweni, uvunula iinthimba zalapho enda khona. Umalokazana wembatha isithimba, iphotho, iinrholwani ezimbili enyaweni ngalinye bese atatele idzila ngehla kweenrholwani. # KABOKENI PROVINCIAL TRAFFIC INSPECTOR ARRESTED FOR CORRUPTION

**MPUMALANGA** - A 39-years-old Provincial Inspector Nkosinathi Emmanuel Masina, based at Kabokweni Cost Centre was arrested by members of the Hawks Serious Corruption Investigation Mpumalanga on Friday 23 April 2021 for alleged corruption.

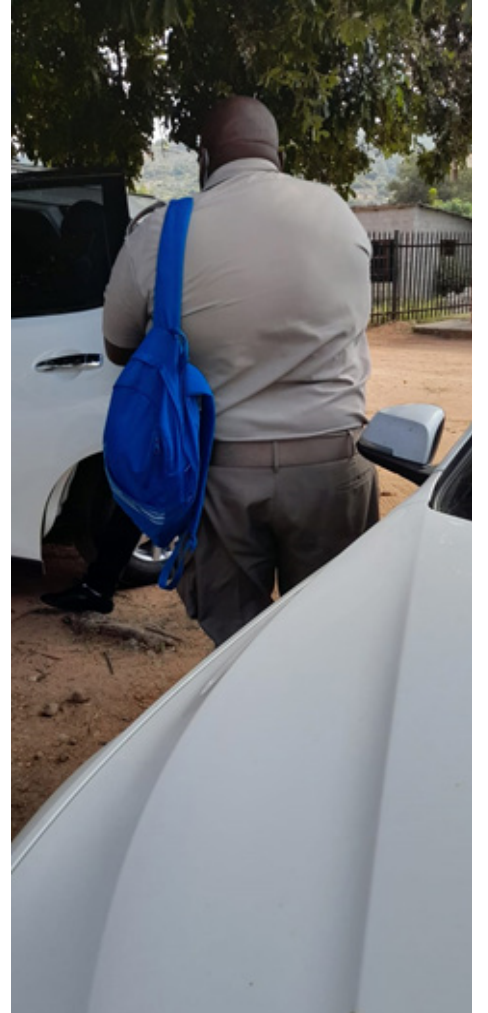
It is alleged that Thursday 30 January 2020 the complainant was driving a company truck loaded at the back along Badplaas and Barberton road when he was stopped by the traffic officials. It is further alleged that the traffic officer searched the truck and told the victim that he is not allowed to load people at the back of the truck.

The traffic officer allegedly removed the disc and demanded R1500.00 in order for him to return the disc. The complainant did not have money at the time and the traffic officer decided to struck the truck from the road and he promised him that he will get the disc back when he bring the money. The matter was reported to the Hawks Serious Corruption Investigation Nelspruit, which led to the arrest of the suspect on Friday. He appeared before the Barberton Magistrate Court on Monday 26 April 2021.

The accused was released on R1000 bail and the case in transferred to Nelspruit Commercial Crime Court until 12 May 2021.

# MPUMALANGA MASTER OF HIGH COURT AND HER COMPANION BACK IN COURT FOR TRIAL

**MPUMALANGA** – The Mpumalanga Master of High Court Bina Masuku (46) and her companion Elvis Kgosiemang (37), arrested by the Hawks Serious Commercial Crime Investigation team on the 07 November 2019 for Fraud, Corruption, Money Laundering and Contravention of the Immigration Act appeared before the Nelspruit Commercial Crime Court for trial in 21 April 2021. Masuku was denied bail and remanded in custody while her companion Kgosiemang released on bail of R30 000.

The arrest followed the investigation, which was launched by the Serious Commercial Crime Investigations probing the alleged siphoning of claimants funds from the Masters office for almost two years.

It was established that the senior official allegedly directed claimants to her unqualified “lawyer” boyfriend to process the claims. Some claimants never received their monies, instead it was shared amongst the two. Approximately R1.7 million has since disappeared from twelve families.

The enquiries have revealed that the boyfriend is not a lawyer and she misrepresented the state by claiming to be a South African.

The Department of Home Affairs’ Immigration Division has finalised their investigation into her status in the country.

The probe into the matter further linked the two companies Zanvise multi holdings(PTY) LTD and Tanvise trust service(PTY) LTD as accused number three and four respectively, they were also charged.

During the court appearance the defense requested a postponement of the case in order for them to prepare for representation of the added accused.

The matter was postponed to 17, 18 and 20 May 2021 for trial. The witnesses were warned to appear in court on the 17 May 2021 for trial.

Bina Masuku remains in custody while the bail for Elvis Kgosiemang is extended until the next court date.

# MPUMALANGA SUSPECT SOUGHT FOR FRAUD

**MPUMALANGA** – Members of the Hawks Serious Commercial Crime Investigation in Mpumalanga are seeking assistant from the public to locate the whereabouts of Oscar Mathe (45) who is wanted for alleged fraud.

It is alleged that in April 2014 two former bank officials from Malelane and Tonga respectively colluded and re-activated a dormant business bank account of deceased person. They

created new beneficiaries who are their relatives in order to transfer money into their accounts where it was consequently withdrawn. The stolen money amounted to approximately R417.000.

A case was opened in August of 2014 and brought before Court. The court ordered for the tracing of the beneficiaries and warning statements were obtained except Mathe who disappeared with R40 000. Mathe reportedly used to drive taxis around Bushbuckridge town. He is known to frequent Jo-

hannesburg particularly in Germiston, Makause squatter camp. Attempts to trace him have so far been unsuccessful and a warrant of arrest was issued against him on 29 August 2018.

# REAL ESTATE AGENT LINKED TO FRAUDULENT SALE OF RDP HOUSES RE-ARRESTED

**MPUMALANGA** – Annica Van Staden (46), a real estate agent sought by the Hawks' Serious Commercial Crime Investigation team was re-arrested by the team from her hiding place in Boksburg Gauteng Province on Monday 26 April 2021.

The arrest follows her recent publications on the media as wanted suspect dating back on 20 April 2021. It is alleged that the suspect was selling Reconstruction and Development

Programme (RDP) houses without the knowledge of the owners.

The buyers allegedly paid money into her business trust account, trading as "Housing First Eiendom". As soon as the money was received into her account, it would be transferred to her accomplices.

It is further alleged that Van Staden was arrested in Protea Glen, Soweto in August 2019 for fraud and she was released on bail and the matter was postponed to 11 November 2020 but she evaded court. Consequently a warrant of arrest was issued against her.

A further investigation linked her with other cases of fraud worth a total value of approximately R184 000.00. These cases are in Orange Farm, Nelspruit, Lydenburg and Piet Retief, where more than 36 potential witness-

es laid complaints against her.

The Hawks swiftly acted on information from the community about her hiding place. The team proceeded to the address and found her with all her luggage packed and ready to flee. The suspect was arrested and will appear before the Middelburg Magistrate Court on Wednesday, 28 April 2021. More arrest is imminent.

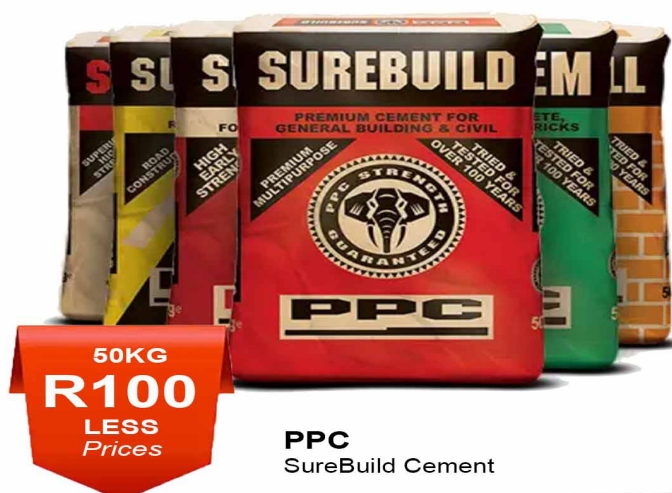
